ELIGIBILITY REQUIREMENTS

- A completed Drake State Admissions application
- An official high school transcript that includes your first semester senior year grades if you are currently enrolled in high school
- **An official transcript from EACH college or university attended if you are a transfer student or if you have attended any postsecondary institution including Drake State Community and Technical College**
- A letter of reference from a school/college official (principal, counselor or instructor) or an employer
- Complete the 2017-2018 or the 2018-2019 **FAFSA** online at <http://www.fafsa.ed.gov> using Drake's College code **005260**.
- A 250-word essay explaining the need for a college education, your interest in J. F. Drake State Community and Technical College and your plans for using the scholarship funds.
- Must be U.S. citizen or provide documented evidence of U.S. citizenship, including naturalized citizenship, U.S. permanent residency status, U.S. resident alien status and U.S. alien status.

GENERAL INFORMATION

The J. F. Drake State Community and Technical College Scholarship is a tuition assistance program. Scholarships may be retained for the duration of a program provided all other requirements are met. The evaluation committee will determine the type of scholarship the recipient will receive.

REQUIREMENTS:

1. All scholarship recipients must be enrolled for a minimum of 12 credit hours per semester.
2. All Scholarship recipients must maintain a minimum overall G.P.A. of 3.0 on a 4.0 scale for the **Academic** scholarship or at least 2.5 on a 4.0 scale for the **Leadership** scholarship.

Scholarship funds may be used during the summer session provided the recipient enrolls for 12 credit hours.

Once final grades have been validated and affixed to the high school transcript, along with the graduation date, students must request official copies to be sent to Admissions(1) and Financial Aid (1).

NOTE TO APPLICANTS: It is imperative that all items (front and back) be completed for proper awarding of scholarships. Please type or print using black ink only. All incomplete applications will be ineligible.
